699/22 Apologies for Absence

Apologies for absence were received from T Howell and R Hill Harmsworth

700/22 Declaration of Interests

There were no declarations of interest

701/22 Public Forum

A member of the public raised an issue about a drainage channel off the football field which was directing excessive water on to the allotments. The Clerk to speak with the grounds maintenance contractor

A further issue was raised about a blocked drain at Stainsby – Clerk to report to County Councillor and DCC highways

A member had received a complaint from the resident of Cobblers Cottage at Stainsby. There had been 6 traffic incidents over the past two months on the dangerous bend at Stainsby where their property stood. It was agreed that the County Councillor and a representative of highways be asked to attend a site meeting to discuss what measures could be put in place.

It was further reported that there had been no progress on the provision of a directional sign for Bramley Vale School Clerk to raise with County Councillor

702/22 Minutes of Parish Council Meeting held 13th December 2022

The minutes of the meeting of the Parish Council held on 13th December 2022 were approved and confirmed as a true record.

704/22 Report of County Councillor

Councillor Barron was not in attendance

705/22 Report of District Councillor

Councillor Clough reported on information produced by the Electoral Commission about registering to vote and about the new regulations relating to the provision of ID when attending the polling station. It was agreed that the information be

publicised as widely as possible in the parish.

Report of Manager

The Manager submitted a report to members who were happy with the content and supportive of the proposals he was making.

707/22 Parish Projects

Sculpture

The Clerk was delighted to report that she had at last been able to set up a contract for an unmetered supply for the sculpture with SSE. Members were also supplied with a written update from the Arts Officer at BDC detailing matters around the transfer of ownership of the sculpture from BDC to AHPC, the Virtual Sculpture project, which would enable the viewing and exploring of the sculpture in 3D for anyone to enjoy, the development of a short film of the orchestra project and proposals for a celebration and switch on event in March. Members received the report.

Ramp

709/22 Applications for Grant Aid

There were no applications for grant aid.

710/22 Financial Matters Budget and Precept 2023/2024

The Clerk distributed copies of the expected outturn of income and expenditure for 2022/2023. The Clerk explained to members that, due to a considerable increase in the level of support required for staffing at the Centre, and other non recurring expenditure during 2022/2023, there had been a steady reduction in the level of reserves which would result in reduced balances to carry forward to 2023/2024. The Chair explained the effect of a proposed small increase of the precept to cover expected increased costs in the coming year. The Clerk further reported that 70% of the properties in Ault Hucknall parish fell into Bands A and B. It was therefore Proposed by T Trafford, Seconded by P Clough and Resolved unanimously by show of hands, that a precept of £42000 be levied which was an increase of £1500 on the previous year's figure and resulted in an increase on the cost to a Band A property 7p per week, Band B 8p per week and Band D property of 10p per week. The overall increase of the precept was 3.71%
