147/19 Apologies for Absence

148/19 Declaration of Interests

T Howell declared an interest in Item 12 on the agenda.

149/19 Public Forum

150/19 Minutes of Last Meeting

The minutes of the last meeting of the Parish Council held on 15th January 2020 were approved and confirmed as a true record

151/19 Police Matters

The police were not present.

The P&CC had requested parish councils to consider the issues they believed were the priority for the future. Members considered that issues of drug dealing and county lines activity should be prioritised, together with better liaison between local policing, the parish councils and the community and more evidence of police presence and activity.

Members also considered an invitation to a Town and Parish Councils Evening at the police headquarters on 16th March and Councillors L and D Adsetts-Moseley agreed to attend on behalf of the Parish Council

152/19 Report of County Councillor

Councillor Moesby was not present but had reported that he had reported the bad state of the road between Stainsby and Tibshelf Road. He had also recently arranged for CREST to undertake speed checks on A617

153/19 Report of District Councillor

Councillor Clough reported that she had

attended the musical evening at the Centre and congratulated the organisers Attended training events on chairing meetings and solar power and battery storage

Visited 'Young Voices' and spoken to them about their main concerns which they said were litter, traffic, dog poo and bullying.

Attended a presentation from the IVenture Group which had been very inspiring

Been involved in a 12 hour traffic count at Glapwell crossroads which had identified over 20,000 vehicles during that time

Visited Bramley Vale School to deliver some books and experienced great difficulties with parking in that area

She also reported that BDC had received the Inspectors report who were satisfied with the Local Plan

Provisional arrangements had been made for the consultant to deliver a presentation to a joint meeting of representatives from Ault Hucknall Parish Council and Heath and Holmewood Parish Council on Tuesday 3rd March at Doe Lea Centre. Firm arrangements would be circulated to members once the arrangements had been finalised.

156/19 Servicing of Dog and Litter Bins

The Clerk reported receipt of the pricing for the servicing of dog and litter bins by BDC for 2020/2021 which would be £3.50 per bin per empty totalling £1454.05. It was Resolved that BDC be requested to continue with the service for 2020/2021.

157/19 Doe Lea Centre

The Manager submitted a report which was distributed to all Members and is appended to the minutes. The Manager pointed out that some occasions had arisen when it was difficult to cover cleaning duties due to staff sickness and holidays. It was therefore agreed that a relief cleaner be appointed on an annualised contract of between 30 to 60 hours per annum.

Ramped Access

Changing Room Refurbishment

The Clerk had spoken with Brian concerning the possibilities for improvement to the changing room facilities. The main issue was the size of the home and away team changing rooms which were not large enough to accommodate the number of players. As it was not possible to extend the current facilities because of the structure of the building, a possible suggestion was to offer the existing changing rooms for sale and to research the cost of providing a replacement facility which meets the current needs. The Clerk was asked to research whether there was any funding available which could be accessed to support the project.

Stainsby School

The Clerk provided members with a draft copy of a letter to the National Trust. It was agreed that the letter covered the issues raised by the Parish Council and that it be sent to the Director General and the Chair of the National Trust.
