5. Centre Improvements/Maintenance:

The old creche room is now empty and awaiting repainting. All minor repair work has been completed however this has flagged up a possible wasp nest in the roof void. – Advice is being sought from a pest control specialist.

Quotes to make improvements to the Computer Suite were coming in at the top end of what I was expecting (\sim £15,000). As such I have decided to postpone this project until the next financial year to allow more time to look at funding bids and getting best value quotes.

I have suggested the Centre as a location for an EV charging port with ChargeMyStreet and am awaiting to hear back from them.

6. Centre session updates:

Whilst sessions currently show good and improving numbers the new restrictions may change this. Masks will once again be required whilst moving around the building and for the majority sessions in line with government guidance.

All regular sessions will finish w/e Friday 17th December with most restarting the week beginning 10th January 2022.
