#### 450/21 Declaration of Interests

#### 451/21 Public Forum

R Holland attended the meeting. He had very kindly taken over the management of the Doe Lea Football Pitch following the death of his father. He explained that there were some repair issues with the changing rooms as well as the need to provide some extra facilities. He explained that there was also a need to replace the goal posts. The Clerk was asked to research some costs for the work and to investigate the replacement of the goal posts. Robert explained that there were two teams currently using the pitch –Clay Cross Dynamos who were in the North Derbyshire Youth League and used the pitch for games on Saturdays and training during the week, and Doe Lea FC who used the pitch on Sundays. They currently had 23 players on their books.

Members also discussed the area of ground near the children's play area. It was agreed that investigations be made into the possibility of developing this into an additional parking area and five-a-side all weather pitch.

Lisbeth Adsetts-Moseley reported on the current situation with regard to the development of Bramley Vale School. Two new classrooms were going to be added with the building extending on to the playing field. There was to be new cladding to improve the insulation.

# 452/21 Minutes of Parish Council Meeting held 22<sup>nd</sup> September 2021 and Special Parish Council meeting held 12<sup>th</sup> October 2021

The minutes of the meeting of the Parish Council held on 22<sup>nd</sup> September 2021 and the Confidential minutes of the meeting held on 12<sup>th</sup> October 2021 were approved and confirmed as a true record.

## 454/21 Report of County Councillor

Councillor Barron attended to meeting and reported on the issues of speeding on A617. He had been lobbying for the installation of camera at Doe Lea and on The Hill. He explained to members that there were plans for extensive development of more than 950 houses on the border of Derbyshire which was adding weight to the argument for the Shirebrook Access Road/By Pass. He also reported that the grant he had available for parish councils to support celebrations for the Queen's Platinum Jubilee would be £400 per parish not £300 as previously reported.

# 456/21 Grants for Planting Trees

Members had received information concerning the availability of grant aid by the Tree Council for the planting of trees and hedgerows. They considered a number of possibilities and it was agreed that these be discussed with Rebecca Hill-Harmsworth who had sourced the information. Members also were reminded that there had been an offer via Bolsover District Council looking for planting sites for trees provided through the Woodland Trust.

#### 457/21 Neighbourhood Plan

Andrew Towlerton, the consultant, had now sent through plans of the parish on which work could be carried out in developing the Neighbourhood Plan. It was agreed that a meeting of the Neighbourhood Plan group be arranged prior to the next meeting of the parish council

#### 458/21 Doe Lea Centre

The Manager submitted a report which is attached to the minutes of this meeting. It was agreed that an item be placed on the next agenda to discuss the provision of subsidised tickets for Live and Local Performances.

#### 459/21 Christmas Tree

Members discussed the possibility of siting a Christmas Tree at Bramley Vale. The Clerk was asked to investigate the necessary approvals required. It was agreed that, if possible, a rooted Christmas Tree be installed with facilities to attach solar lights with back up battery. The Clerk to report to the next meeting of Council.

was due to some issues with the legal pack. It was understood that the intention was that the auction would be re launched when the legal issues had been dealt with.

#### **5.** Centre Improvements/Maintenance:

After a recent fire risk assessment review some issues we're found with external lighting. This has now been rectified by replacing defective bulbs and installing solar powered lighting in unlit problem areas.

Repairs have been made to the games area after issues with loose panels were identified on a recent risk assessment, these were completed by the BDC playground inspector, and we have requested regular visits from the BDC playground inspector. The repairs have cost around £350. I am still waiting for the cost of inspection to be confirmed.

If the trustees would like a visit to site to talk about the latest projects, look at current improvements and talk about future plans for the Centre then do get in touch with me to arrange a time.

#### **6.** Other items:

We have been approached by Marie from the Pleasely Welfare Band who became aware of the brass instruments via a third party and have asked if we would consider donating these to the band for use by their children and young people. I advised that any decision on donating the assets would have to go through the trustees and as a minimum requirement, assurances would need to be made that they were kept for community usage in line with original funding.
